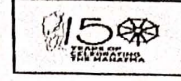

ORDER NO: 06(18)/2023

1. The Applicant Shri N.J.Heera had filed an offline RTI application dated Nil seeking information under the Right to Information Act, 2005.
2. I find that the above said application was received in the RTI section on 29.05.2023.
3. After carefully examining the request of the applicant, information was called for from the concerned Section of C.S.M.I. Airport, Mumbai which are under the jurisdiction of this CPIO.

Accordingly, para-wise reply from the CSMI Airport Commissionerate to the information sought by the applicant is as under:

- i) '-----it is submitted that in consequent to the Passenger's Baggage (Levy of fees) Regulations, 1966 (Notification No. 111-Cus. dated 08.06.1966), the rates of Warehouse Charges, for any package in case of:
- (a) detained on request of the passenger,
 - (b) detained against request of the passenger,
 - (c) in case of seized goods,
 - (d) in case of confiscated goods, released under orders of Commissioner (Appeals)/ Revisionary Authority separately,
 - (e) in case of confiscated goods released under orders of Court, where the courts have found irregularities/ illegality in seizure cases, &
 - (f) in case of confiscated goods released under orders of the Courts on Technical grounds, are as follows:-

1 st Week	2 nd Week	3 rd Week	4 th Week	5 th Week Onwards
Free	150/-	300/-	300/-	500/-



However, the copies of Public Notices in this regard (i.e. Public Notice No. 21 dated 26.02.1976 and Public Notice No. 102 dated 09.07.1985), are not readily available and will be provided as and when available."

13. "----- the charges are collected on the basis of authority given in Notification issued by CBIC."

4. Accordingly, the RTI Application dated 11 received on 29.03.2023 filed by Shri M.J.Sharma under RTI Act, 2005 is disposed of.

5. An Appeal under Section 19 of the RTI Act, 2005 against this order lies before the Adml. Commissioner of Customs & First Appellate Authority, CSMI Airport, Mumbai - 400099, Maharashtra within 30 days of receipt of this order.
