- iii. List of work locations/places of postings under the Public Authority where physical devices have not been installed.
- iv. Reasons for non-installation of devices at those work locations.
- v. Total cost incurred in rupees towards A.M.C. for the physical devices during the calendar year 2023.
- vi. Copy of Circular issued in light of DoPT OM dated 23.06.2023 labeled with F.No. 11013/13/2023 Pers. Policy A.III
- vii. Number of employees registered on the AEBAS under the Public Authority.
- viii. BAS Report – No. of employees Vis-à-vis Attendance Hours.
- ix. BAS Report – No. of employees working less than 4 hours excluding Saturday, Sunday & holidays.
- x. BAS Report – Number of employees Repeated Late Comers List.
- xi. In light of DoPT OM dated 23.06.2023 mentioned at Sr.No.6, number of cases where action has been initiated against officers appearing in BAS Report mentioned at Sr. No. 10, during the years 2023 & 2024 till date of furnishing reply. Please provide information for 2023 & 2024 separately.
- xii. Name & Designation of the officer responsible for initiating such action.
