1. Mr. Siddhesh Kastoori, (hereinafter referred as the applicant) filed online application, bearing registration no CCUM3/R/E/24/00044 dated 03.03.2024, under the Right to Information Act, 2005.

2. The applicant has sought following information:

i . Quantity (in litters & bottles) of Scottish Cider (6.7% Alcohol by Volume) he can bring as a passenger from London for personal use to go through green channel at Mumbai Airport

ii . If, he exceeds the green channel limit what would be the Customs duty charged for Scottish Cider (6.7% Alcohol by Volume) costing 6 pounds for 500 ml bottle?

3. The above said application was received in this section on 03.03.2024. Perusal of the application indicates that the data sought by the applicant does not fall under the purview of information as defined under the Act. The applicant has sought clarification/ consultation regarding goods to be brought by him. Such clarification or interpretation is outside the purview of the Act. All the information regarding eligibility of a passenger to claim duty free allowances, the duty liability, the exemptions- are readily available in public domain under the various notifications/circulars/clarifications issued by the CBIC.
