**1. The applications were received in this section on 18/03/2024 and 19.03.2024 respectively. As the applicant has sought same information vide his applications, they are taken up in this reply. The information sought by the applicant is as follows(reproduced verbatim):-

- 2.**      1. *kindly provide the vendor name and contract no. (as mentioned on gem contract) of the vendors hired for providing the vehicle in offices of all directorate in your jurisdiction in last 3 years. And provide the details that how many taxi no. /commercial no. Vehicle hired by the said offices.*
2. *Kindly provide the vendor name and contract no. (as mentioned on gem contract) of the vendors hired for providing the MTS and DEO etc; staff in offices of all Directorate and Commissionerates of Delhi, Mumbai, Jaipur, Ahmadabad zone in your jurisdiction in last 3 years. And provide the UN No./PPF a/c No. and name of the all MTS & DEO etc working in the said offices during last 3 years?*
3. *How many Directorates and Commissionerates in your jurisdiction are registered at online RTI portal ?*
4. *Is Directorate like- DGAP, DGARM, NAPA, DGGSTI, DG Legal Affairs, DG CRCL and most of the customs Commisionerate are registered at online*

**3.**      The information sought at Sr. No. 1& 2 by the applicant constitutes third party data and is exempt from disclosure under section 8(1)e of RTI Act, 2005. Information sought at Sl No. 3 and 4, is general in nature. However it is informed that this Commissionerate, viz; Mumbai Airport Commissionerate, is registered at online RTI portal

**4.**      The RTI Applications dated 18.03.2024& 19.03.2024, are accordingly
