Applicant Shri Deepak Sharma(hereinafter referred as the applicant) filed online application bearing registration CCUM3/R/E/24/00058 dated 31/03/2024, under the Right to Information Act, 2005. The information sought by the applicant is reproduced verbatim:-

- "1. Kindly provide the laws or rules and regulations related to the the Gold or diamond jewellery that a passenger can wear the ornaments during their international travel from abroad (Asian countries) to India.
- 2. Kindly provide the maximum legal limit of quantity of gold jewellery that can a passenger carry them by wearing the jewellery during their international air travel from abroad (Asian countries) to India without legal declaration in customs at international airport.
- 3. Please send the certified true copy of information and its relevant documents by speed post in physical form/hard copy to applicant."
- 2. The above said application was received in this section on 31.03.2024. The applicant has sought information regarding Customs Laws/Rules/ procedures regarding eligibility of passenger to claim duty free allowances, the duty liability, the exemptions etc. These are situational clarifications sought by the applicant and the CPIO is not required to give any opinions, clarifications, views or comments on any subject or reply to situational questions. Moreover, queries/clarifications/interpretation of information is outside the purview of the Right to Information Act, 2005 and the same has been reiterated by the higher appellate forums like Hon. CIC and Courts, in various judgments. The information sought by the applicant is readily
