Mr. Gaurav Anil Vyas, (hereinafter referred as the applicant) had filed online application vide registration no. CCUM3/R/E/24/00078 dated 07/05/2024 under the Right to Information Act, 2005. The information sought is reproduced verbatim:-

- "1. Provide a Certified copy of the notification or circular under which the Customs authorities at Mumbai Airport have been charging warehousing fees.
- 2. The date of issuance of the aforementioned notification or circular.
- 3. Any amendments or revisions made to this notification or circular, if applicable.
- 4. Any guidelines or procedures provided to Customs officials for implementing and collecting warehousing charges from passengers at Mumbai Airport.
- 5. Any records of discussions, meetings, or decisions related to the imposition of warehousing charges by the Customs authorities at Mumbai Airport.
- 6. Any other relevant documents or information pertaining to the imposition of warehousing charges by the Customs authorities at Mumbai Airport."
 - **2**. Warehouse charges are collected on the basis of Passenger's Baggage (Levy of fees) Regulations, 1966 (Notification No. 111-Cus. Dated 08.06.1966).

Public Notice No. 21 dated 28.02.1976 and Public Notice No. 102 dated 09.07.1985 are the two notices issued specifying the warehouse charges for goods stored in Airport. Despite all efforts, copy of these notices could not be traced in the Commissionerate. The rates currently charged are:

1st Week	2nd Week	3rd Week	4th Week onwards
Free	Rs. 150/-	Rs. 300/-	Rs. 500/-
