Mr. Amritpal Singh Khalsa, (hereinafter referred as the applicant) had filed online application vide registration No. CCUM3/R/T/24/00101 dated 14/11/2024, under the Right to Information Act, 2005. Vide this application the information sought is reproduced below:-

“Anant Ambani's and Radhika Merchant's wedding was held in July 2024, where dignitaries from all over world visited the wedding and gave exquisite gifts. Please inform me whether custom duty is paid on the foreign gifts given to Anant Ambani and Radhika Merchant by the foreign dignitaries. Kindly provide me total amount of customs paid on foreign gifts. Kindly inform me if any amount is outstanding towards customs duty. Kindly provide me list of the expensive foreign gifts Anant Amabni and Radhika merchant received in their wedding. Please provide me receipts of custom duty paid on foreign gifts.”

2 . The information sought by the applicant was received from the concerned section and the same is reproduced below:

“Whenever any Indian/Foreign passenger arrives at Mumbai International Airport, the purpose of their visit to India is not recorded during Customs clearance. Therefore, the information regarding Customs Duty paid by foreign dignitaries/guests specifically for the wedding of Mr. Anant Ambani and Smt. Radhika Merchant is not available.”

3. The RTI Application dated 14/11/2024 is accordingly disposed of. An Appeal under Section 19 of the RTI Act, 2005 against this order lies before Ms. Nancy D'souza, Addl. Commissioner of Customs & First Appellate Authority, CSMI Airport, Mumbai – 400099, Maharashtra within 30 days of receipt of this order.
