"On April 1, Delhi Customs tweeted that 106 DJI drones were seized from passengers who arrived from Hong Kong under Customs Act.

For the financial years 2023-24, 2022-23, 2021-22, 2020-21, 2019-20, please furnish the following information regarding similar seizure of foreign drones and/or drone parts by Mumbai Customs from the airport passengers and cargo.

1) Total number of such seizures made at Mumbai airport in a year-wise format.

2) Total number of cases registered along with number of drones and their value as adjudged by Customs.

3) Total number of passengers arrested.

4) Total number of foreigners among passengers arrested and their nationalities.

5) Current position of these cases as far as trial is concerned ."
