PUBLIC NOTICE No. 46/2025

M/s. Air India Express Limited, having their registered office at Block 4, Vatika One-on-One, Sector 16, NH-48, Industrial Estate, Gurgaon-120007, Haryana has requested for permission of transshipment of Imported and Exported cargo meant for transshipment by air to/from Air Cargo Complex, Mumbai to Twenty six (26) destination Customs station viz. Amritsar, Bengaluru, Bhubaneswar, Chennai, Delhi, Goa (Dabolim), Goa(mopa), Jaipur, Hyderabad, Chandigarh, Indore, Kannur, Kozhikode, Kolkata, Lucknow, Bagdogra(Siliguri), Guwahati, Mangalore, Madurai, Patna, Pune, Trivandrum, Tiruchirappalli, Varanasi, Vishakhapatnam, Cochin within India.

2. M/s. Air India Express Limited has executed Bond of Rs. 1,10,00,000/- (Rupees One Crore and Ten Lakhs only) for transshipment of Import Cargo and Bond of Rs 2,00,00,000/-(Rs Two Crores Only)for transshipment of Export Cargo by Air from /to Air Cargo Complex, Mumbai to/from destination Customs stations, valid upto 13.04.2026.

3. And, M/s. Air India Express Limited has submitted a Bank Guarantee for Import Transshipment amounting to Rs. 16,50,000/-(Rupees Sixteen Lakhs Fifty Thousand Only) and a Bank Guarantee for Export Transshipment amounting to Rs 36,00,000/-, both valid upto 16.07.2026 issued by Kotak Mahindra Bank Ltd, Commercial Branch, Gurgaon on behalf of M/s. Air India Express Limited for Import and Export Transshipment Cargo.

4. M/s. Air India Express Limited has also submitted that AI Airport services Limited (AIASL) will be the custodian for M/s Air India Express Limited for handling of TP shipments at BOM Air cargo Terminal.

5. Now, therefore, in exercise of the powers vested in me under Section 45(1) of the Customs Act, 1962, I, NILANK KUMAR, Commissioner of Customs (General), Air Cargo complex Mumbai hereby grant the permission to M/s. Air India Express Limited, for the purpose of transshipment of Import and Export cargo meant for transshipment by air from/to Air Cargo Complex, Mumbai to Twenty six (26) destination Customs Station viz. Amritsar, Bengaluru, Bhubaneswar, Chennai, Delhi, Goa (Dabolim), Goa(mopa), Jaipur, Hyderabad, Chandigarh, Indore, Kannur, Kozhikode, Kolkata, Lucknow, Bagdogra(Siliguri), Guwahati, Mangalore, Madurai, Patna, Pune, Trivandrum, Tiruchirappalli, Varanasi, Vishakhapatnam, Cochin within India and appoint /s. AI Airport services Limited, as Custodian (Customs Cargo Service Provider) for the purpose of transshipment of Import and export cargo meant for transshipment by air to/from Air Cargo Complex, Mumbai to Twenty Six (26) destination Customs station.

6. Transshipment of Import and export Cargo being permitted as per this Public Notice shall be governed by:-

- The provisions of Chapter VIII of the Customs Act, 1962
- Goods Imported (Conditions of Transshipment) Regulations, 1995.
- Handling of Cargo in Customs Areas Regulations, 1995.

- d. CBIC Circular No. 69/99-Cus dated 06.10.1999 as amended by Boards Circular No. 61/2000-Cus dated 13.04.2000, 79/2001-Cus dated 07.12.2001 and 06/2007-Cus dated 22.01.2007
 - e. Public Notice No 23/2000 dated 08.11.2000 read with Public Notice No 12/2004 dated 27.03.2004, Public Notice 18/2005 dated 28.07.2005 and Public Notice No. 09/2007 dated 02.03.2007.
 - f. Any other Rules, Regulations, Notifications, Instruction, Circulars and Public Notices issued from time to time.
7. The said permission shall be valid till 13.04.2026 i.e the earliest date of expiry of required bond/bank guarantee submitted by M/s Air India Express Limited as mentioned in para 2 and 3 above.
