PUBLIC NOTICE No. 63 /2025

M/s InterGlobe Aviation Ltd. having their registered office at Upper Ground Floor, Thapar House, Gate No. 2, Western Wing, 124 Janpath, New Delhi-110001 was granted permission for transshipment of Import and Export cargo by air from/to Air Cargo Complex, Mumbai w.r.t. sixteen (16) destination Customs Stations - Amritsar, Ahmedabad, Bangalore, Calicut, Kolkata, Coimbatore, Cochin, New Delhi, Goa (Goi/Gox), Hyderabad, Indore, Jaipur, Lucknow, Chennai, Nagpur, and Varanasi within India vide Public Notice No. 95/2024 dated 24.12.2024.

2. M/s InterGlobe Aviation Ltd. has executed a Bond of Rs. 40,00,00,000/- (Rupees Forty Crores only) for transshipment of Import cargo and Bond of Rs. 75,00,00,000/- (Rupees Seventy-Five Crores only) for transshipment of Export cargo by Air from/to Air Cargo Complex Mumbai valid from 10.12.2025 till 09.12.2028.

3. M/s InterGlobe Aviation Ltd. has submitted a Bank Guarantee amounting to Rs. 60,000,000/- (Rupees Six Crore Only) valid till 09.12.2026 for Import Transshipment Cargo and a Bank Guarantee amounting to Rs. 11,25,00,000/- (Rupees Eleven Crore Twenty Five Lakhs Only) valid till 09.12.2026 for Export Transshipment Cargo, both executed by Yes Bank Ltd. on behalf of M/s InterGlobe Aviation Ltd

4. M/s InterGlobe Aviation Ltd. has requested for renewal of permission for the purpose of transshipment of Import/Export cargo meant for transshipment by Air from/to Air Cargo Complex, Mumbai to/from seventeen (17) destination Customs stations - Amritsar, Ahmedabad, Bangalore, Calicut, Kolkata, Coimbatore, Cochin, New Delhi, Goa (Goi/Gox), Hyderabad, Indore, Jaipur, Lucknow, Chennai, Nagpur, Varanasi and Mangalore within India.

5. Now, therefore, in exercise of the powers vested in me under Section 45(1) of the Customs Act, 1962, I, Hardeep Batra, Commissioner of Customs (General), Air Cargo Complex, Mumbai hereby further renew the permission granted vide Public Notice No. 95/2024 dated 24.12.2024 to M/s InterGlobe Aviation Ltd., for the purpose of Transshipment of Import and Export cargo

meant for transshipment by air from/to Air Cargo Complex, Mumbai w.r.t. seventeen (17) destination Customs Stations - Amritsar, Ahmedabad, Bangalore, Calicut, Kolkata, Coimbatore, Cochin, New Delhi, Goa (Goi/Gox), Hyderabad, Indore, Jaipur, Lucknow, Chennai, Nagpur, Varanasi and Mangalore within India and appoint M/s InterGlobe Aviation Ltd., as Custodian (Customs Cargo Service Provider) for the purpose of transshipment of Import and Export cargo meant for transshipment by air from/to Air Cargo Complex, Mumbai w.r.t. 17 Customs Stations within India.

6. Transshipment of Export cargo being permitted as per this Public Notice shall be governed by:-

- i. The provisions of Chapter VIII of the Customs Act, 1962
- ii. Goods Imported (Conditions of Transshipment) Regulations, 1995.
- iii. Handling of cargo in Customs Areas Regulation, 2009 (as amended),
- iv. Boards Circular No. 69/99-Cus dtd. 06.10.1999 as amended by Boards Circular No. 61/2000-Cus dtd. 13.07.2000, 79/2001-Cus dtd 07.12.2001 and 06/2007 dtd 22.01.2007.
- v. Public Notice No. 23/2000 dtd 08.11.2000 read with Public Notice No. 12/2004 dtd. 27.03.2004, Public Notice No. 18/2005 dated 28.07.2005 & Public Notice No. 09/2007 dtd. 02.03.2007.
- vi. Any other Rules, Regulations, Notifications, Instructions, Circulars & Public Notices issued from time to time.

7. The permission granted by this Public Notice shall be valid till 09.12.2026 i.e. the earliest date of expiry of the required Bond/Bank guarantee submitted by M/s InterGlobe Aviation Ltd.
