Sealed quotations are invited from reputed, experienced, and eligible vendors for providing Transcend Drivepro Body 10 Wireless Body Camera, Full HD 1080P, Sony STARVIS, 2 Yrs Warranty, built-in Battery, DPB10C, 64GB as per details given below:

1. Name of Work

Procurement of Fourteen (14) Body Worn Cameras with video/audio recording facility, built-in battery and storage.

2. Scope of Work

- a. The scope of work shall include:
 - Supply of Body Worn Cameras with the following minimum features
 - High-definition video recording with audio (Full HD 1080P)
 - Built-in rechargeable battery
 - Built-in internal storage (64 GB)
 - Date and time stamping of recordings
 - Wearable design suitable for field use
- b. Supply of all standard accessories required for operation (charging cables, clips, mounts, etc.
- c. Two-year comprehensive warranty (minimum) against manufacturing defects
- d. Delivery of equipment at the designated office location
- e. Demonstration and basic operational guidance, if required

3. Eligibility Criteria

The bidder must fulfil the following conditions:

- The firm should be a local / reputed vendor/ manufacturer or an authorized dealer/supplier of Body Worn Cameras
- The firm should be registered under GST and possess a valid GSTIN
- The firm should have at least **2 years' experience** in supply of electronic surveillance/recording equipment to Government / PSU / reputed private organizations
- Authorization letter from manufacturer (in case of authorized dealer) must be enclosed • The firm should not have been blacklisted by any Government department Supporting documents in proof of eligibility must be enclosed with the quotation.

4. Estimated Cost
