Structure & Frame

- Reinforced base support system
- Anti-corrosive metal folding/slide mechanism
- Designed for frequent conversion between sofa and bed modes

Seating & Sleeping Comfort

- High Resilience (HR) Foam / PU Foam / Latex Foam options
- Multi-layer foam cushioning for balanced seating and sleeping comfort
- Durable S-spring or equivalent support system
- Firm yet comfortable mattress base suitable for overnight use

Upholstery & Finish

- Premium fabric upholstery (Suede/Velvet/Bouclé/Jute/Linen or equivalent)
- Precision stitching and proper seam alignment
- Smooth tensioned fabric without sagging
- Easy-clean, low-maintenance fabric preferred

Functionality

- Smooth and noiseless opening/closing mechanism
