1. Technical Specifications

The sofa should conform to the following minimum specifications:

Structure & Frame

- Kiln-dried solid hardwood frame
- Moisture-controlled wood to prevent warping
- Reinforced internal wooden base support system
- Strong, balanced solid wood legs with protective buffers
- Anti-Sag construction, Cane sides and melamine polish

Seating & Support

- High Resilience (HR) Foam layers for long-lasting shape retention
- Multi-layer comfort construction (high-density + medium-soft foam combination)
- Heavy-duty springs for even weight distribution and durability
- Designed for long-term performance under regular office use

Upholstery & Finish

- Premium quality upholstery (Suede/Velvet/Bouclé/Jute/Linen or equivalent options)
- Smooth fabric tensioning without wrinkles or sagging
- Precision stitching with clean seam alignment
- Symmetrical cushion shaping with consistent piping
- Final quality inspection before delivery

Design

- Contemporary / modern design suitable for office interiors
- Customizable finish (wood polish/fabric shade to be finalized at time of order)
